- Arranges counselling and guidance programs arranged for the fresher's and parents regarding ragging.
- Canvases about anti-ragging in the forms of Flexes, Posters and Boards in college premises and surrounding areas where there is a chance of ragging.
- Provides helpline details inside and outside college premises.
- Resolves the complaint received from the victim.

Responsibility:

- To receive any grievance/complaint from student regarding harassment.
- To investigate the case based on the above mentioned complaints related to harassment with 10 working days.
- To conduct a systematic enquiry on receiving any complaints from aggrieved students and submit a detailed report to the undersigned for suitable action.
